

## Chicago Style Guide (Author/Date)

Reference citation in the text should be as follows.

### *Single author*

Blinksworth (1987, 125)

(P. Brown 1991) — if the ref list includes two or more works by different authors with same last name and date

### *Two or three authors*

(Finburn and Cosby 1990)

Smith, Wessen, and Gunless (1988)

### *More than three authors*

(Zipursky et al. 1959)

If two refs would give the same citation then use first two names, the group of names in full or short title to differentiate.

### *Volume and page number*

(Wazinski 1989, 3:114)

### *Multiple references*

(Light 1972; Keller 1896a, 1896b, 1907; Smith 1941, 45–49; 1944, 105)
